Hello,

This message might come as a surprise, or maybe not. I don't know. It may also be awkward. If so I apologize for any discomfort. And I'm not sure who might read this. My intention here is to acknowledge you as the ones accountable for the mission in this reality, especially E'Asha. I know that I was supposed to help more directly with this mission. And so far I have failed to accomplish that.

So in the spirit of "let's try something different this lifetime" for the last few years I've been making radically different choices than any other iteration of this mission. One example is writing this email.

And there are two main reasons for writing now. First, to ask if there is intention or desire at core shield to heal the split of the local shield? E'Asha said several times in workshops after the split that people on the shield would be coming back together. I can see/feel that starting to happen in small groups. Is that still seen at core shield as a key potential for this mission?

And second, I'm writing to be completely transparent about my website. I feel you may already be aware of it. But it's important to plainly tell you that I am doing it from a space of altruism, healing, integrity and most of all love. I ask that if there are any concerns you let me know so we can try to find a solution that does not result in a take-down demand which has the undesired effect of silencing my voice one last time. Now, back to the first reason ... gauging intention and desire for healing the shield. It's easy to recognize that every time this mission failed it occurred after disharmony and a split of the shield (that pattern is all throughout the teachings). And for me this also gets back to what I said above. I know I was supposed to be more directly involved with this mission. As always I will most certainly respect the free will choice of those running this mission. But there is really no transparency about what has been happening at core for the past year. So, I have no way of knowing where core shield stands. So in the spirit of "why not at least give it a try" ... :)

So, I have attached a design for a site that could be a big win-win. It could easily produce more than enough passive income to make E'Asha and her team financially independent. And it would create a powerful learning tool for students of the teachings. I've also attached my resume for your consideration. I recently found out that my consulting job (which I've had for the past 6 years) is suddenly ending. So, I'm looking for my next job. And I could not do my job search with KRYSTHL integrity if I didn't at least try to work at the job I know I intended coming into this life ... working in support of impeccable healing.

You may notice that I have my time volunteering at Aurora Earth listed on my resume. Actually, Matthias and Mac gave job references for me when I left Aurora Earth to get my IT consulting position at <company name redacted>.

And I should also tell you that I have submitted the Web design several times, to several people over the past 6 years. I know it was reviewed by both Mac and A'SaN. I heard directly from Mac that A'SaN decided (mid 2011) not to proceed with the project. Mac shared that he was sincerely very impressed with the design, but there was not enough money to proceed. Even after I clarified that the project could be self-funded and liquid within a year's time, the answer was still "no".

So, I'll share the same clarifications here ... There could be minimum up-front money by asking for early-adopters to subscribe prior to completion of the site in return for locking-in a lifetime discounted monthly cost ... \$24, or maybe \$48 per month. With just 500 early-adopters that generates \$12 - \$24K per month. (Early adopters could also get some value by getting emails of custom search results generated using Adobe Acrobat Pro to help them find information in the teachings while they wait for the site to be completed).

Then when the site is completed new subscribers might pay \$72 or more per month. An additional 500 subscribers at that rate would add at least \$36K per month. And I think 1000 subscribers to the teachings is a very conservative estimate of the potential market. Of course there are hosting costs and there would need to be a lot of work done to set up the site. But maybe you can see the win-win? And to be completely transparent, I'm suggesting that I be included to work on creating this site and that it include search results from all the teachings (1998 – present). That is why I'm sending my resume to show that I have more than 3 decades of this type of professional experience. I can provide professional and personal references for your consideration as necessary.

I trust you sense my intentions for writing this email are based in love.
