FINAL JUDGMENT OF DISSOLUTION OF MARRIAGE

THIS CAUSE having come on to be heard on the Amended Petition for Dissolution of Marriage filed by the Wife, DIANE K. DEANE, and on the Counter-Petition for Dissolution of Marriage filed by the Husband, MICHAEL C. DEANE, and the Court, after reviewing the pleadings filed in this cause and being otherwise fully advised in the premises finds as follows:

1. That this Court has jurisdiction over the parties and the subject matter of this action.
2. That the Husband and Wife were lawfully married to each other on October 23, 2000 in Sarasota, Florida.
3. That there are no minor children born as a result of this marriage and none are expected.
4. That the Wife has been a resident of the State of Florida for more than six (6) months next before the filing of her Amended Petition for Dissolution of Marriage.


5. That the marriage between the parties is irretrievably broken.
 6. That on June 17, 2014, the Husband and Wife entered into a Marital Settlement Agreement.
 7. That the Wife's stage name is E'ASHA ASHAYANA ARHAYAS.
- It is, therefore,

ORDERED and ADJUDGED as follows:

1. That the bonds of marriage between the Husband, **MICHAEL C. DEANE**, and the Wife, **DIANE K. DEANE**, are hereby dissolved because the marriage is irretrievably broken.
2. That the Marital Settlement Agreement between the parties introduced into evidence and marked Exhibit "ONE" is approved, ratified and incorporated in this Final Judgment by reference and the Husband and Wife are ordered to comply with it.
3. That the Wife's stage name is given to her and she shall now be known as E'ASHA ASHAYANA ARHAYAS.
4. That the Court retains jurisdiction over the parties and the subject matter of this action for the purposes of enforcement of this decree and to adjudicate all reserved upon issues and for all other purposes legally allowed by law.

MARITAL SETTLEMENT AGREEMENT

MICHAEL C. DEANE, hereinafter called "Husband", and DIANE K. DEANE, hereinafter called "Wife", in consideration of the mutual covenants hereinafter contained, covenant and agree as follows:

The Wife shall not intentionally go to, in or within 500 feet of the Husband, his automobile or his residence. The Husband shall not intentionally go to, in or within 500 feet of the Wife, her automobile or her residence. There shall be no contact between the parties via telephone, the Internet or texting.

MINOR CHILDREN

4. There were no minor children born as a result of this marriage and none are expected.

ALIMONY

5. There shall be no alimony paid by either party to the other and each party releases the other from any claims to alimony now or in the future.

ATTORNEY'S FEES AND SUIT MONIES

6. The Husband and Wife shall pay their own attorney's fees, suit monies and court costs.

ARMED FORCES

7. Neither party is a member of the Armed Forces of the United States of America.

8. The parties represent to each other that:
- A. Each has had independent legal advice by an attorney of their selection in the negotiation of this Agreement. The Husband is represented by Roger E. O'Halloran, Esquire, and the Wife is represented by Michael L. Resnick, Esquire. Each party fully understands the facts and has been informed fully about their legal rights and obligations. Each is signing this Agreement freely and voluntarily, intending to be bound by it.
 - B. There are no representations or warranties other than those set forth in this Agreement.
 - C. Each party is informed of the law of Florida concerning the power of the courts under certain conditions to modify the terms of this Agreement.

DEBTS AND OBLIGATIONS

9. The parties represent and covenant to each other that hereafter neither party will incur any debts or make any contracts for necessities or other expenses for which the other party may be responsible. Each party agrees to indemnify and hold the other party harmless from any such liability resulting from such party's obligations heretofore incurred except as otherwise stated herein and or in any attached exhibits hereto which exhibits are incorporated herein by reference.

PLEDGE OF CREDIT

10. Neither the Wife nor the Husband shall pledge or engage the credit of the other and neither shall incur or contract any debt or obligation upon which the estate of the other could be held liable.

MUTUAL RELEASE

11. Except as otherwise provided in this Agreement, each party releases the other from all claims or demands up to the date of the execution of this Agreement. Except as otherwise provided in this Agreement, each party waives, releases and relinquishes all rights that he or she

may now have or may hereafter acquire as the other party's spouse under the present or future laws of any jurisdiction:

- a. To elect to take against any Will or Codicil of the other party now or hereafter in force;
- b. To share in the other party's estate; or
- c. To act as executor or administrator for the other party's estate.

RELEASES

12. Each party hereby releases forever any claim, legal action or right that they may have against the other party or the property of the other party up to and including the date of the execution of this agreement. Hereafter, neither party has a claim or right to the property of the other or to property that is acquired hereafter by the other or a claim or demand against the other except as is specified in this agreement except as otherwise stated herein and or in any attached exhibits hereto which exhibits are incorporated herein by reference.

NO PROMOTION OF DISSOLUTION OF MARRIAGE

15. It is understood that this Agreement is made in contemplation of dissolution of marriage, but it is also understood that it is not intended to facilitate or promote the dissolution of marriage nor to produce directly or indirectly the procurement of a dissolution of marriage, but it is agreed that this Agreement shall become a part of any Final Judgment of Dissolution of Marriage entered by a Court of competent jurisdiction involving the parties hereto. Notwithstanding incorporation into a Final Judgment, this Agreement shall not be merged in it but shall survive the judgment and be binding on the parties at all times.

ENTIRE AGREEMENT

16. This instrument contains the entire agreement between the parties and no representation or agreement that is not incorporated in it is valid.

RECONCILIATION

17. In the event of a reconciliation between the parties, this Agreement shall continue in full force and effect without abatement of any terms or provisions hereof unless by amended or written agreement and fully executed by the parties, with the same formalities of this Agreement.

GOVERNING LAW

18. The laws of the State of Florida shall govern the validity, construction, interpretation and effect of this Agreement. This Marital Settlement Agreement is, in fact, the result of joint negotiations between Husband and Wife and their counsel. Accordingly, no presumption shall arise nor a heavier burden be imposed on the author of this Agreement, as both parties and their counsel have contributed toward and collectively approved the language.

BREACH OF AGREEMENT

19. Should either party breach the terms of this Marital Settlement Agreement, causing the other party to employ an attorney for the enforcement of the provisions of this Marital Settlement Agreement, or for the collection of damages as a result of said breach, or for the collection of any monies due under this agreement, then the prevailing party's attorneys' fees and suit money will be paid by the non-prevailing party.

EQUITABLE DISTRIBUTION PAYMENT

20. The Wife, within ten (10) days from the date of the execution of this Marital Settlement Agreement by the parties, shall pay to the Husband the sum of TWO HUNDRED AND FIFTY THOUSAND DOLLARS (\$250,000.00) as an equitable distribution payment. This equitable distribution payment shall not be taxable to the Husband as alimony for income tax purposes. This equitable distribution payment shall not be deductible by the Wife as alimony for income tax purposes.

MARITAL DOMICILE

21. The Husband upon receipt of the equitable distribution payment in the amount of TWO HUNDRED AND FIFTY THOUSAND DOLLARS (\$250,000.00) as set forth in paragraph 20 of this Marital Settlement Agreement shall have sixty (60) days from the date he receives this payment to vacate the marital domicile and find another place of residence, however he shall immediately upon receipt of this payment deliver to the Wife a quit claim deed deeding, transferring, assigning, and conveying to the Wife all of his right, title, and interest in and to the marital domicile located at

The Wife, within sixty (60) days from the date of paying the sum of TWO HUNDRED AND FIFTY THOUSAND DOLLARS (\$250,000.00) to the Husband, shall take exclusive possession of this property. If there are persons other than the Husband living in the marital domicile, he shall make sure that these individuals also vacate the premises within the time specified herein.

The parties recognize that the Husband has been in exclusive possession of said property since October 2010. The Husband shall pay all household expenses incurred by him from October 2010 until he vacates the marital domicile. Household expenses are defined as alarm service, cable t.v., pest control, pool service, lawn service, repairs and maintenance, natural gas, telephone, water, garbage, sewer, electricity, homeowner's associate fees, mechanics liens, maid service, and winter cleaning service, and shall hold the Wife harmless for payment therefrom. 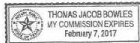

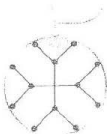
